
Managing Risk in the Fund

The SVS Cornelian Defensive RMP Fund is managed within Cornelian risk level A on a risk scale of A to E (A being the lowest and E being the highest risk). This upper expected risk limit is calculated by an independent third party and is based on the historical volatility of asset classes held within the fund.
